VETERANS BENEFITS

In this economy, it is important to take advantage of all the benefits and services that are available to you. The Department of Veterans Affairs (VA) has a lot to offer former service members and their survivors to assist them in these hard times.

The main categories of assistance include medical care, monetary benefits based on service-related illnesses, monetary benefits based on financial need and unemployment, burial benefits, and monetary benefits for surviving spouses.

Medical Care: If you have never enrolled in the VA Health Care System, you should consider enrolling. If you qualify, the VA provides a full range of preventive outpatient and inpatient services. Once you enroll, you can be seen at any VA facility across the country. There are many ways to qualify to receive this medical benefits package. To find out more, call 1-877-222-8387 (VETS). You can also go online to <http://www4.va.gov/healtheligibility/> to complete and submit a basic eligibility form.

Compensation benefits (monetary benefits based on service-related illnesses): If you have a health problem that began during service or was caused by an incident in service, you may qualify to receive monthly compensation benefits. To be considered for this, you must have been discharged under conditions other than dishonorable. You can apply by filling out VA Form 21-526, *Veterans Application for Compensation and/or Pension*, or by completing an online form at <http://vabenefits.vba.va.gov/vonapp>.

Pension benefits (monetary benefits based on financial need and unemployment): If you served at least 90 days with one day during a recognized period of war and are over 65 or unemployed due to disability, you may qualify to receive monthly pension benefits. To be considered for this, you must have been discharged under conditions other than dishonorable, have family income and net worth below a prescribed limit, and not be disabled due to your own willful misconduct. A higher rate of pension may be payable if you are confined to your home (housebound) or require the help of someone to assist you with the activities of daily life (require aid and attendance). You can apply by filling out VA Form 21-526 or completing the online form as mentioned above.

Burial benefits for burial in a National Cemetery: These benefits include a gravesite with available space, opening and closing of the grave, perpetual care, a government headstone or marker, a burial flag, and a Presidential Memorial Certificate at no cost to the family. Burial benefits for spouses and dependents include burial with the veteran, perpetual care, and inscription of the name and date of birth of the deceased on the veteran's headstone at no cost. Eligible spouses and dependents may be buried even if they die before the veteran does. For more information about eligibility to burial in a National Cemetery, visit <http://www.cem.va.gov/bbene/eligible.asp> or call 1-800-827-1000.

Burial benefits for burial in a private cemetery: These benefits include a government headstone or marker, burial flag, and a Presidential Memorial Certificate at no cost to the family.

Monetary burial allowance: Some veterans may qualify for a monetary allowance to offset funeral costs. You may be eligible if you paid for the burial or funeral, have not been reimbursed, and the veteran was discharged under conditions other than dishonorable. In addition, the veteran must have *either* died from a service-related condition; been in receipt of or entitled to receive compensation or pension at the time of death; died while hospitalized by VA or under VA contract care; died while on authorized travel at VA expense; or died on or after October 9, 1996, while a patient at a VA-approved state nursing home. To apply you can fill out VA Form 21-530, *Application for Burial Benefits* and attach a copy of the veteran's discharge document (DD Form 214), death certificate, and funeral/burial bills. You may download the form at <http://www.va.gov/vaforms/> or call 1-800-827-1000 to have one mailed to you.

Monetary benefits for surviving spouses: There are two types of monthly benefits available to the surviving spouses of veterans who were discharged under conditions other than dishonorable. These benefits are Dependents Indemnity and Compensation (DIC) and Death Pension. A surviving spouse can apply for either of these benefits using VA Form 21-534, *Application for Dependency and Indemnity Compensation, Death Pension and Accrued Benefits by a Surviving Spouse or Child*.

DIC Benefits: DIC benefits are payable to the surviving spouses of veterans whose death was related to their military service. A higher rate of DIC may be payable if the surviving spouse is confined to his/her home (housebound) or requires the help of someone to assist with the activities of daily life (requires aid & attendance).

Death Pension benefits: Death Pension benefits may be payable to the surviving spouses of veterans who served at least 90 days with one day during a recognized wartime period and whose deaths were not related to their military service. In addition, the surviving spouse must have family income and net worth below a prescribed limit. A higher rate of death pension may be payable if the surviving spouse is confined to his/her home (housebound) or requires the help of someone to assist with the activities of daily life (requires aid & attendance).

These are only some of the benefits that VA has to offer.
